- Judicial and Administrative Authorities, (Fulfillment of judicial and administrative follow-up procedures and dispute resolutions)

Legal Grounds of processing personal data

Your data is collected in written and in electronic environment during the establishment of your legal relation with RTC Suite and the term of such relation from you, our suppliers, business partners and also legal authorities through communication channels and established on our website ,agreements and electronic mail instruments.

Your personal data collected with this way is processed on the basis of legal compliance reasons specified in the articles 5,8 and 9 of the Law on the Protection of Personal Data listed below :

-Having explicit consent

-Clearly laid in the Laws

-Provided that it is related to a contract which is necessary to process the personal data -Data processing is mandatory establishment , exercise or protection of a right

-Compulsory for RTC Suite to fulfill its legal obligation

-When data processing is mandatory for the legitimate interests of Data Controller considering that it does not harm the fundamental rights and freedoms of the data subject.

Your Rights In Accordance With Article 11 of the LPPD
